RULES & REGULATIONS:

- 1) All choreographers can participate in the competition WANTED: CHOREOGRAPHERS 2011 (2011 International Young Choreographer Project). There is no age limit and they are asked to present an original piece (not necessarily new).
- 2) There is only one category without specific style.
- 3) Maximum length: 15 minutes. Performers: minimum 2.
- 4) In order to apply send by ordinary mail (do not send certified or registered mail) the following material:
 - registration form;
 - n.1 DVD, (not to judge your work but it is just to have an idea of your dance idiom), or a link to your video sharing channel such as YouTube, Vimeo, etc. instead;
 - curriculum of the choreographer (max 300 words);
 - choreography sheet;
 - brief presentation of your work and your artistic motivation (max 200 words);
 - performers sheet;
 - medical certificate for each performer;
 - receipt of the payment;
 - exemption form and waiver of liability for injury and loss, and images publication release filled out and signed by each participant/performer.
- 5) All attached forms must to be filled out on the computer and printed afterwards.
- 6) All participants (performers included) must be 18 years old.
- 7) Registration fee is Euro 150,00. Registration fee is not refundable.
- 8) Payment is due by bank transaction with the info listed below:

- 9) Selections will take place within the various events that WDA Europe organizes. There will be organized more than one selection through Italy in different cities. The First selection will take place on a stage or

performance space created for the occasion.

The Choreographers who pass the First selection are invited to return to the Final selection (or to the eventual Second selection, if the Commission needs to view again the work).

10) Choreographers who pass the First selection and who participate to the Second/Final one are required to pay an additional fee of Euro 50,00.

11) The Final Gala will be held in 2011, date and place to be established.

11) The schedule for rehearsals, performance programs, technical equipment and various communications will be send by e-mail by WDA Europe.

12) All music must be burned on a single track CD to be presented in 2 copies. Please write on yours CDs title, choreography and musical credits, length. CDs will not be returned.

13) During the selections it is prohibited to take photos or video the event, unless authorized first by WDA Europe.

14) Only one person per choreographer other than the performers can have access to the stage. This person must have a pass given to him by WDA Europe upon request.

15) The Commission is made up of personalities from the performing arts field (in the case that one or more members, due to uncontrollable facts, are not present the Commission will work with the members present). The Artistic Direction of WDA Europe will chose the winner after having heard both the audience and the Commission.

16) The Award goes to the best Choreographer: \$1,200.00 & hotel in Taiwan for 3 weeks. The winner has a 3 week residency in Tsyong, Taiwan, to create a new piece that will be performed at the Tsyong Theatre - South Taiwan (for the value of over Euro 15.000,00).
